CAMP UTOPIA RENTAL POLICY
FOR ALABAMA CHURCH OF GOD GROUPS AND/OR FAMILIES

1. Groups of less than 100 people will be charged \$4.00 per person. Larger groups over 100 will be 3.00 per person.
2. Due to the high cost for small groups there will be a **minimum** charge of \$100.00

There may be more than one group using the grounds at the same time. All charges still apply per group. We ask for full cooperation with the schedule presented by the State Office for use of the cafeteria, pool, other facilities and recreation equipment when more than one group is present.

3. Renters must provide the following 30 days in advance of the rental date:
 - a) A non-refundable deposit of \$100.00 or one-half of total rental amount, whichever is greater. Check made payable and mailed to: Church of God State Funds, P. O. Box 19765, Birmingham, AL 35219
 - b) Certificate of insurance with all attachable or applicable riders showing proof of both medical and liability coverage.
 - c) Lifeguards for both men and women, if applicable, with certification with either American Red Cross or acceptable alternative certification.
4. Each group is responsible for the cleanliness of the grounds before leaving. All trash is to be placed in the proper containers and any equipment used is to be returned to its place of storage. Please see the camp ground caretaker regarding any questions relative to these matters.
5. In the event that a Church of God family desires to use the facilities, there is a \$15.00 fee per day for camper parking.
6. For rental of other buildings and equipment, see Addendum #1. (NOTE: Church of God groups receive a 20% discount off Addendum published rates.)
